# **BOG News**

About half of Quail Run property owners were in attendance at the May Annual Meeting, which is about he same number usually present. Since only three people had chosen to run for the three vacancies on the Board, there obviously was no competition. Yet, ballots were submitted by over 88% of owners (by beneficial interest).

**Bob Reid,** who will remain as Treasurer on the new Board, went over the balances in the operating, working, and reserve accounts. He went over the final costs of the roof project and noted that it came in very close to the cost estimated about a year ago, and that at this point, over three fourths of the owners had paid their portion in full. The expense covers the full replacement

of the roof, placement of Ice & Water shield beyond what is required merely by code, engineering studies and project supervision, larger gutters, replacement of the wood previously under the gutters with vinyl, legal expenses, and management costs.

We are planning on painting all the buildings at this point with the roof project now completed. The trim will be painted over to cover the nails used, even though the vinyl itself really doesn't need it. The cement siding will be painted the same color as the vinyl siding on the dormers. We will have enough money in the budget to cover the cost without any assessment. The grounds came through the mild winter in



Is there any treatment? Yes there is and often consultation with your doctor is the first steps to better leg health. You may need prescription compression socks and stockings which help support weakened veins and may enable you to lead a pain-free active life. These compression stockings are available in below the knee, thigh high or full pantyhose types. The internet is a good place to begin your search for compression stockings. I have found a brand that is relatively easy to put on, at least compared with other brands I have tried. These stockings are sold according to size of the ankle, calf and thigh and are available in quite a few sizes and colors. The manufacturer that I have had good luck with is Mediven and the stockings are called Mediven Comfort. However, they are pricey but they do last quite a while and do help with assisting the blood return to your heart. If you are traveling by plane or car, it is important to get up and walk frequently and even when sitting to practice dorsiflexion which is the raising and lowering of your toes while the heel remains on the floor.

# <u>How essential are prenuptial agreements for seniors?</u>

When my clients plan to marry, I advise them that a prenuptial agreement should be considered before they take that life-changing step.

When individuals have reached their senior years, the prenuptial agreement takes on new significance, as much more may be at stake than people realize. Your net worth may exceed that of your future spouse, and by age 50+ you may have accumulated:

- •A lifetime of savings
- •Retirement funds
- •Ownership in, or profits from the sale of, a family business
- •Home equity
- •Money from a divorce settlement or inherited from a deceased spouse
- •Inherited property that you want to remain in your family.

Even if your net worth is equivalent to that of your future spouse you may have different goals in mind for your assets when it comes to spending in your retirement years, planning for long-term care costs and inheritances for your respective families.

When two people marry, they immediately have legal rights in each other's assets in the event of divorce or death. Even if there are already wills, trusts and other ownership arrangements in place, the legal rights of a spouse trump many of these dispositions. Children or grandchildren's inheritances could be substantially diminished in the event of your passing. **prenuptial agreements** (continued from left) about the counting of spousal assets. Accordingly, it is crucial that spouses wishing to protect assets engage in proper estate planning.

True, no one can predict the future, but they can prepare for it. The process of structuring a prenup opens both parties up to an honest and enlightening financial discussion before the marriage. The agreement delineating how resources will be divided upon divorce or death is a way to avoid protracted legal battles in the case of divorce, separation or death.

If you are a senior and are considering marriage, evaluating the benefits of having a prenuptial agreement — with an attorney skilled in estate planning and prenuptial agreements — should be a fundamental part of your marriage plans. Each party should have a separate attorney to represent respective interests in structuring a prenup. 


# The Master Key

## Choosing a Nursing Home; Plan in Advance if Possible

Finding the right nursing home is a daunting task most of us will face, as two-thirds of people over 65 will need a nursing home, at least temporarily, according to AARP. It's best to research facilities in advance, but a sudden illness or injury may force you to confront things sooner than you expect. Here are several key considerations:

- Stay close. The biggest influence on the quality of care nursing home patients receive is often the frequency of visits by friends and family. Make sure you'll be allowed to visit when you want — from early morning to late evening.
- Get references. Your local Area Agency on Aging or hospital discharge planners can provide listings of nearby nursing homes. Medicare caseworkers, at 1-800-MEDICARE, also can help. Stick to facilities certified by Medicare. They're inspected every year, and any complaints are investigated. Read recent inspection reports, usually available through the state health department. One accident isn't a big deal, but frequent reports of falls, bed sores, and the like are a red flag.
- Check on staffing. No matter how dedicated individual employees are, if there aren't enough, care suffers. Check the ratio of aides to patients. The Centers for Medicare and Medicaid Services require each patient have a daily minimum of 2.8 hours of nursing aide time and 1.3 hours with an RN or licensed practical nurse. Ask specific questions about care. Can your mom keep her current doctor? Who decides whether to change your dad's medicine, and will you be notified first? What's the policy on handling patients who get agitated?
- Scope it out. Snoop around and beware anyplace that objects. Check resident rooms for cheerfulness and safety. Use the bathroom to see

if there's enough hot water. Inspect the kitchen for cleanliness. Are patients smiling? Is it peaceful? Does it smell pleasant and homey? Stay for a meal. Is the food appetizing?

# Area Highlights

#### ASSABET RIVER NATIONAL WILDLIFE REFUGE



George and I recently found a real gem for bikers, hikers, and nature lovers. This is hidden away in nearby Sudbury. The Assabet River Refuge is also open for wildlife observation, photography, hunting and fishing.

The complex gives emphasis to local wildlife and habitats you will find at the Assabet River NWR. There are interactive exhibits, such as pull out drawers with specimens inside, wildlife sounds and question/answer panels. If you are bringing kids, ask for a scavenger hunt to match the taxidermy animals with their habitat! Children also love the "Night Room" which is an interactive showing of the wildlife you will see and hear at night.

There is a pond with a canoe launch. You can visit an Army bunker about a tenth of a mile from the Visitor Center. Aside from local wildlife exhibits, the Visitor Center also features indoor and outdoor panels that examine the history of the area. These exhibits focus on early Native American inhabitation of the watershed, European farming settlements of the area, and the military occupation of the former Fort Devens Sudbury Annex which covered the land which is now the refuge.

An asphalt trail circles the complex and is suitable for hiking and biking. There are a total of 15 miles of trails with maps available. There is a multipurpose room and a nature store.

The store features field guides, wildlife themed toys, books, historic maps and Assabet Refuge hats. There are restrooms available.

A variety of programs are presented throughout the year. On Wednesday, June 27 at 7pm the author Sy Montgomery will give a talk on forays into Birdology. This talk will be illustrated with striking images and stories.




# ASSABET RIVER NATIONAL WILDLIFE REFUGE (Continued from left)


**Directions:** Take Main Street Hudson towards Sudbury. The Refuge is just beyond the Fire Academy, on the left,



relatively good shape. The utility panels will be hidden by planting greenery, not covered over with vinyl fencing previously considered. Scheduled painting of the decks will be resumed next year. Most of them are in good condition, although some unstable railings have been noted, and these are being repaired by a crew from Alpine Management.

This month, letters will go out to some owners for attention to problems noted with the fire sprinklers in their units. Inspection is required by our insurer, and we have to be in compliance. Some units could not be inspected because the inspectors could not get inside, and a schedule will be set up to try to accommodate them at this point. Some mechanical problems were noted and Quail Run will pay to have them fixed. In other units, the sprinkler heads have been stained or painted over or obstructed, and this must be corrected at the unit owner's expense.

At the Annual Meeting held on 16 May, 92 unit owners were represented in person or by proxy, totaling 61.33 % of the beneficial interest.



You can easily select a rectangular, circular, or elliptical area. Paint.net supports layers, which allows all sorts of ways to manipulate images. You can, for example, create double exposures, easily altering one part of the picture while leaving the rest alone. (Yes, you can do this with the selection tool, but layers provide more safety and flexibility. A selection can disappear with a wrong mouse click; a layer can't.) You can also insert your cat into a seascape if that's your pleasure.

FotoFlexer If your goal is quick photo fixes, or you don't want to install another program, FotoFlexer is worth a try. This Cloud-based service, financed with advertising (which is only occasionally annoying), offers a significant set of photo manipulation tools. And it's exceptionally easy to use.



Start by going to the FotoFlexer at: http://fotoflexer.com/and clicking Upload Photo. (Ignore the big, green Download here button you might see.) Once a picture is uploaded and on-screen, you'll find a clear, tab-

and icon-based user interface for altering it.

The first button you'll want to click is Fullscreen, which gets rid of the advertising. (The advertising comes back when you click away from FotoFlexer, so you'll probably have to press that button a few times.)

FotoFlexer does quite well when you need to adjust lighting. The Basic tab's Adjust icon gives you three sliders to quickly change hue, saturation, and lightness. The Contrast control offers the typical combination of contrast and brightness sliders. (What's the difference between lightness and brightness? The first affects the entire picture evenly, while the sec-

ond concentrates on the lighter parts of the picture.) The Geek tab (yes, that's its name) has a Curves control which behaves much like the like-named tool in Paint.net.

By George Champine **OLED is coming.** Even though television is quite a mature technology, rapid advanced continue to be made. Liquid



Crystal Display (LCD) technology is now the norm, and the recent advance was to replace the fluorescent back lights with the smaller and more flexible Light Emitting Diode (LED) backlights that give much improved colors. Now, Organic Light Emitting Diodes (OLED) technology is replacing the LCD displays. Instead of the back light shining through the LCD screen, the OLED emits light itself and no back light is required. Therefore the OLED TVs are very thin (1/8<sup>TH</sup> inch) and the colors are very bright with deep blacks and stunning picture quality. The 55 inch TVs from LG, Sony, and Samsung, which will be available at the end of the year, weight about 18 pounds. As usual they will be expensive, but the price will come down rapidly.

Wireless Printers. Many people in Quail Run have a wireless router because of the convenience it provides. Recently, wireless printers have become available at reasonable prices that have the advantages of being able to place the printer anywhere, and being able to print from several computers to the same printer.

Free Cloud Storage. Several companies are now offering "cloud" storage, for example Dropbox, Microsoft's SkyDrive, and Google Drive. These services are roughly similar. You get several gigabytes of free storage just for signing up. By installing a small Windows app, you get the ability to synchronize that storage with the hard drive on your PC, where you can manage them using Windows Explorer. You can sync files and folders with other PCs and Macs, access them from mobile devices, and share them with other people.

The simplest scenario of all is personal file backup. Keeping your important files in a folder that is continually synchronized with an online storage service gives you a backup security blanket. If your local drive

crashes, you can recover those files quickly and easily. A side benefit of this approach is that it allows you to access files easily from multiple devices. If you have a desktop PC and a notebook, for example, you can start working on a file in your office. Whatever changes you make are synchronized to the online copy. Grab your notebook, head off to the airport, and you can pick up where you left off—as long as you have access to an Internet connection.

Both Google and Microsoft offer the ability to create and edit a variety of document types directly in a web browser. With Dropbox, you can view common formats but you need third-party apps to enable the same editing scenarios.

Online viewing and editing means you don't need to worry about whether you'll have the right app installed—if you can open your online file storage location in a browser, you can get your work done.

Free Photo Editing Packages. One of the most popular uses of computers by senior citizens is digital photography. However, sometimes the pictures need retouching to crop or adjust colors. The best retouching packages cost \$50 to \$100, but here are three free packages that will do the job for most people.

**Picasa from Google.** This is a very good package for the casual user as it is largely self-explanatory. It lacks some of the features of the others however. Find the installation package at: http://picasa.google.com/.

Paint.net from Microsoft provides all the adjustment tools an average digital photographer should need. For instance, if you're not satisfied with a picture's exposure, you'll find four tools on the Adjustments menu for fixing it. Auto-Level may get you what you want without any work at all, but in my experience, it rarely does.

Brightness/Contrast can help if the entire picture is over- or underexposed. But if only parts of the image are off, try either Curves or Levels. I find Curves more useful, as it allows one to minutely adjust the picture. Paint.net's selection tools (which let you copy, delete, and adjust specific parts of an image) don't match Photoshop's, but they're sufficient for most uses.
